History of the Illuminati

By Myron Fagan

Myron C. Fagan, 1887-1972, was married to actress Minna Gombell, 1892-1973. In 1907, at the age of 19, he arrived on Broadway and became the youngest playwright in the History of the American theater. For several years he was dramatic Editor for the Associated Newspapers including, The New York Globe and the Hearst newspapers. Mr. Fagan's career encompassed the theater, journalism, and national politics, a playwright and a Broadway and Hollywood – writer and producer.

In 1945, at the urgent request of **John T. Flynn** (the famous author of *The Roosevelt Myth*, *While We Slept*, and *The True Story of Pearl Harbor*), Mr. Fagan attended a meeting in Washington D.C. where he was shown a set of micro-films and recordings of the SECRET meetings at Yalta attended only by Franklin Roosevelt, Alger Hess, Harry Hopkins, Stalin, Molotov, and Vishinsky when they hatched the plot to deliver the Balkans, Eastern Europe and Berlin to Stalin. As a result of that viewing, Mr. Fagan wrote two plays: *Red Rainbow* (in which he revealed that entire plot) and *Thieves Paradise* (in which he revealed how those men plotted to create the United Nations to be the "housing" for a so-called Communist, One-World Government).

At the same time, Mr. Fagan launched a one man

crusade to unmask the Red Conspiracy in Hollywood which had set about to produce films that would aid that One World Government plot. Out of that came into being the *Cinema Educational Guild*. As a result of the work of the CEG headed by Mr. Fagan in 1947 came the congressional hearings at which more than 300 famous stars, writers, and directors from Hollywood, Radio, and TV were unmasked as the chief activists of the Red Conspiracy. That was when the infamous "Hollywood Ten" were sent to prison. It was the most sensational event of the decade.

From that time on, Mr. Fagan has devoted all of his time and efforts to writing monthly News Bulletins for CEG in which he kept up the fight to alert the American people to the plot to destroy the sovereignty of the United States of America and the ensuing enslavement of the American people in a United Nations' One World Government.

In his sensational recording [the History of the Illuminati], he reveals the beginning of the One World enslavement plot that was launched two centuries ago by one Adam Weishaupt, an apostate Catholic Priest who, financed by the House of Rothchild, created what Weishaupt called the *Illuminati*. Mr. Fagan describes with documentary evidence, how this Illuminati became the instrument of the House of Rothschild to achieve a **One World Government** and how every war during the past two centuries was fomented by this Illuminati. He describes how one Jacob H. Schiff was

sent to the United States by the Rothschilds to further the Illuminati plot and how Schiff plotted to get control of both the Democratic and the Republican Parties. How Schiff seduced our Congress and our Presidents to achieve control of our entire money system and create the Income Tax cancer and how Schiff and his co-conspirators created the **Council on Foreign Relations** to control our elected officials to gradually drive the U.S. into becoming an enslaved unit of a United Nations, One World Government.

In short, this recording is the most interesting, the most horrifying - and factual - story of the most sensational plot in the history of the World. Everybody who loves our country - who loves God - who would save Christianity (which the Illuminati is dedicated to destroy) - who would save our sons from dying in Korea, in Vietnam, and now on the battlefields of the Middle East, should hear this recording. There is absolutely no doubt that anyone who *does* hear this amazing story will join in the fight to save our country and our nation's youth.

(Myron Fagan's recording took place sometime in the 1960's. This recording was first made on two -78 LP records and sent to every congressman, senator and governor by Mr. Fagan. I (Glen Miller) personally recorded it from the two -78 LP records on to two cassette tapes and now on two CD's - which have been reproduced and distributed by many others. The following is a synopsis

of Mr. Fagan's research and finds also first brought to light by the finds and research of Henry Ford. Please take the time to verify the statements made herein. We don't expect you to take Mr. Fagan's word at face value. We suggest that you visit the Law and Depository libraries that are located throughout your state. The telephone numbers and addresses listed herein are most likely out of date as Mr. Fagan is no longer with us.)

This Satanic plan was launched back in the 1760's and first came into existence under the name of "The Illuminati." This Illuminati was organized by Adam Weishauph, born a Jew. Weishauph was a Jesuit, trained professor of canon law and teacher in a university when he defected to embrace the Luciferian conspiracy.

It was in 1770 that the professional money lenders, the then recently organized House of Rothchild, retained him to revise and modernize the ancient Protocols of Zionism. This from the outset was designed to give the synagogue of satan a blueprint for ultimate world domination. The plan was to impose the Luciferian ideology upon what would remain of the human race after the final social cataclysm precipitated by use of satanic despotism. Weishauph finished his task May 1, 1776, and this is why May 1st is celebrated in all communist nations to this day! On this day he completed the plan and officially organized the Illuminati to put it into execution. This would require destruction of all existing governments and religions. That

objective was to be reached by dividing the masses of people (human cattle) into opposing camps in ever-increasing numbers on political, social, economic and other issues. The opposing sides were then to be armed and incidents provided which would cause them to fight and weaken themselves and gradually destroy all national governments and religious institutions.

A prime feature of the Illuminati plans, when and if their blueprint for world control (The Protocols of the Elders of Zion was discovered and exposed), was to wipe all the Jews off the face of the earth. This would divert suspicion from themselves. If this seems farfetched, bear in mind that Hitler, financed by Krupp, Warburg and the Rothschilds, incinerated thousands of Jews.

Weishauph himself said the word Illuminati was derived from Lucifer and means “holders of the light.” According to him, his plan could bring about a one world government enabling those with mental ability to govern the world and prevent all wars in the future.

Using the words “peace on earth” as his bait, Weishauph, financed by the Rothschilds, recruited 2,000 paid followers. These included the most intelligent men in the fields of arts and letters, education, the sciences, finance and industry. He next established Lodges of the Grand Orient, Masonic lodges, to be their secret headquarters. All this was under orders from the House of Rothchild.

The main features of the Weishauph plan of operation required his Illuminati to do the following things to accomplish their purposes:

(1.) Use monetary and sex bribery to obtain control of men already in high places, in various levels of all government and fields of endeavor. Once influential persons had fallen for the lies, temptations and deceptions of the Illuminati, they would be held in bondage by application of political and other forms of blackmail. Threats of financial ruin, public exposure, physical harm, even death to themselves and loved ones would be used.

(2.) Illuminati on the faculties of colleges and universities were to cultivate students possessing exceptional mental ability, belonging to well-bred families, with international leanings and recommend them for special training in internationalism.

Such training was to be provided by granting scholarships to those selected by the Illuminati. In other words, a Rhodes scholarship means indoctrination that only a one world government can put an end to recurring wars and strife.

All such scholars were to be first persuaded and convinced that men of special talent and brains have the right to rule those less gifted on the grounds that the masses do not know what is best for them, physically, mentally or spiritually.

In addition to the Rhodes scholarships today there

are three special Illuminati schools located in Scotland, Germany and Greece. There are others which are kept under cover.

(3.) All influential people trapped into coming under the control of the Illuminati, plus the students who had been especially educated and trained were to be used as agents and placed behind the scenes of all governments as experts and specialists. There they would advise the top executives to adopt policies which would serve the secret plans of the Illuminati and bring about the destruction of the governments and religions they were elected or appointed to serve.

(4.) Perhaps the most vital directive in Weishauph's plan was to obtain absolute control of the press (at the time the only mass communication media). All news and information would then be slanted to convince the masses that a one world government is the only solution to our many and varied problems.

The Plan Begins

Because Britain and France were the two greatest world powers in the late years of the 18th century, Weishauph ordered the Illuminati to foment the colonial wars (including the Revolutionary war), to weaken the British. They organized the French Revolution to destroy the French Empire.

Weishauph scheduled the French Revolution to

start in 1789; however, in 1784 a true act of God placed the Bavarian government in possession of evidence which proved the existence of the Illuminati. That evidence could have saved France, if it had been heeded.

A German writer named Zwack put into book form the entire Illuminati story with Weishauph's plans. A copy of this book was sent to the Illuminus in France, headed by Robespierre, whom Weishauph had delegated to spark the French Revolution.

The courier was struck and killed by lightning as he rode through Wallistown on his way from Frankfurt to Paris. Police found the subversive documents on his body. After careful study of the plot, the Bavarian government ordered the police to raid Weishauph's newly organized Lodges of the Grand Orient and the homes of his most influential associates.

All of the additional evidence thus discovered convinced the authorities the documents were indeed genuine copies of the conspiracy by which the Illuminati planned to use wars and revolutions to bring about the establishment of a one world government (headed by the Rothchilds).

In 1785 the Bavarian government outlawed the Illuminati and closed the Lodges of the Grand Orient. In 1786, they published all the details of the conspiracy. (The English title is "The Original Writings of the Order and Sect of the Illuminati.")

Copies of the entire conspiracy were sent to all the heads of church and state in Europe but the power of the Illuminati (which was actually the power of the Rothschilds) was so great that this warning was ignored.

Nevertheless, the Illuminati became a dirty word and went underground. At the same time Weishauph ordered Illuminus to infiltrate Lodges of Blue Masonary and form their own secret societies within them and all secret societies. Only masons who proved themselves internationalists and those whose conduct proved they had defected from God were initiated into the Illuminati.

From this time on, the conspirators donned the cloak of philanthropy and humanitarianism to conceal revolutionary and subversive activities. In order to infiltrate Masonic lodges in Britain, Weishauph invited John Robeson to visit Europe. Robeson was a high degree Mason in the Scottish Rite, Secretary of the Royal Society of Edinburg. He did not fall for the lie that the objective of the Illuminati was to create a benevolent dictatorship, but he kept his reactions to himself so well that he was entrusted with a copy of Weishauph's conspiracy for study and safe keeping.

Because the heads of church and state in France were deluded into ignoring the warning given them, the Revolution broke out in 1789 as scheduled by Weishauph. In order to alert other governments to their danger, in 1789 Robeson published

a book, "Proof of a Conspiracy to Destroy all Governments and Religion," but his warnings were also ignored.

There is documentary proof that Thomas Jefferson and Alexander Hamilton became students of Weishauph. Jefferson was one of Weishauph's strongest defenders when he was outlawed by his government. It was Jefferson who infiltrated the Illuminati into the then newly organized Lodges of the Scottish Rite in New England.

In 1789 John Robeson warned all American Masonic leaders that the Illuminati had infiltrated into their lodges. On July 19, 1789, David Pappen, President of Harvard University, issued the same warning to the graduating class and lectured them on the influence Illuminism was acquiring on American politics and religion.

John Quincy Adams, who had organized the New England Masonic lodges, issued warnings. He wrote three letters to Colonel William L. Scone, a top Mason, in which he exposed the fact that Jefferson was using Masonic Lodges for subversive Illuministic purposes. (Those letters are in Wittenburg Square Library in Philadelphia.)

One branch of the Rothchild family financed Napoleon; another branch financed Britain, Germany, and other nations in the Napoleonic wars. Immediately following these wars the Illuminati assumed all the nations would be so destitute and so

war-weary they would be eager for any solution. Accordingly, Rothchild stooges arranged what they called the Congress of Vienna and tried to create a League of Nations, their first attempt at forming a one-world government. On the theory that all the crowned heads of Europe and European governments were so deeply in debt to them that they would willingly or unwillingly serve as their stooges, they pushed their plan.

The Czar of Russia caught the stench of the plot and torpedoed the whole thing. Enraged, Nathan Rothchild (then the head of the dynasty) vowed that someday he or his descendants would destroy the Czar and his entire family. They did exactly this in 1917.

Bear in mind that the Illuminati was never set up to operate on a short range basis. Normally a conspirator enters into a conspiracy with the expectation of achieving an objective during his own lifetime, but not so with the Illuminati. Whether it takes years or even centuries, they have dedicated their descendants to keep the pot boiling until the conspiracy is achieved.

The disastrous rebuff at the Congress of Vienna, created by the Czar, did not by any means destroy the Illuminati conspiracy but forced adoption of a new strategy. The Rothchilds decided that to keep the plot alive they would have to strengthen their control over the money systems of Europe.

Earlier, by a ruse, the outcome of the Battle of Waterloo had been falsified. Rothchild spread a story of a French victory which precipitated a terrific panic on the English stockmarket. When all stocks plummeted down to practically zero, Nathan Rothchild bought them for virtually a penny on the dollar. This gave him complete control of the British economy and virtually of all Europe.

Immediately after the Congress of Vienna boomeranged, Rothchild forced Britain to set up a new Bank of England which he absolutely controlled. Later, Jacob Schiff engineered our own Federal Reserve Act which gave the House of Rothchild a secret control of the economy in the U.S.

In 1826, an American, Captain William Morgan, decided it was his duty to inform all nations and the general public of the full truth about the Illuminati, their secret plans and intended objectives. He also revealed the identities of the masterminds behind the conspiracy.

The Illuminati promptly tried Morgan in absentia and convicted him of treason. An English Illuminist, Richard Howard was ordered to carry out the sentence of execution. Warned, Morgan tried escape by fleeing to Canada, but Howard caught up with him near Niagara Falls and murdered him.

This was verified in a sworn statement made in New York by one Avery Allen who heard Howard render his report of the execution to a meeting of

Knights Templars in St. Johns Hall, New York. He also told how arrangements had been made to ship Howard back to England. This affidavit is still on record in New York archives.

Very few Masons and even fewer of the general public know about the general disapproval this incident caused. Approximately half of all the Masons in the northern jurisdiction of the U.S. seceded. Copies of the minutes of meetings held to discuss that matter are still in existence in safe hands.

All this secrecy emphasizes the power of the Illuminati to prevent leakage of such terrible events of history and to block them from being taught in our schools.

In the early 1850's, the Illuminati held a secret meeting in New York, addressed by a British Illuminist named Wright. Those in attendance were told about the Illuminati organizing to unite the nihilists and atheist groups with all other subversive groups into an international to be known as Communists. This was when the word "communist" first came into being. It was intended to be the supreme weapon and scare word to terrify the whole world and drive the terrorized people into the Illuminati one world scheme. Communism would enable the Illuminati to stir future wars and revolutions.

Clinton Roosevelt (a direct ancestor of Franklin D.), Horace Greeley and Charles Dana (foremost newspaper publishers of that time) were appointed to head a committee to raise funds for this new venture. Of course, most of the funds were provided by the Rothschilds. This fund was used to finance Karl Marx and Frederick Engels when they wrote *Das Kapital* and *The Communist Manifesto* in Soho, England.

Weishauph died in 1830, but prior to his death he prepared a revised version of the age old conspiracy. The Illuminati (under various aliases) was to organize, finance, direct and control all international organizations and groups by working its agents into executive positions at the top.

While Marx was writing the *Communist Manifesto* under the direction of one group of Illuminists, Professor Karl Ritter of Frankfurt University was writing the antithesis under the direction of another group. The idea was that they could use the differences in those so-called ideologies to divide the human race into opposing camps. They could then be armed and brainwashed into fighting and destroying each other. The work begun by Ritter was continued and completed after his death by German philosopher Fredrick Wilhelm Nietche. His ideas were later developed into Fascism, then into Naziism and was used to spark World Wars I and II.

In 1834 revolutionary leader Guisseppe Muzzini

was selected by the Illuminati to direct its revolutionary program throughout the world. Some years before his death in 1872, Muzzini enticed an American general, Albert Pike, into the Illuminati. Fascinated by the idea of a one world government, Pike ultimately became the head of this Luciferian conspiracy.

Between 1859 and 1871, he worked out a military blueprint for three world wars and various revolutions throughout the world. He believed these would forward the conspiracy to its final stage in the twentieth century.

Pike did most of his work in his home in Little Rock, Arkansas. A few years later, after the Illuminati Lodges of the Grand Orient became suspect and were repudiated because of Muzzini's revolutionary activities in Europe, Pike organized the New and Reformed Palladium Rite. He set up three supreme councils, in Charleston, South Carolina; Rome, Italy; and Berlin, Germany and had Muzzini establish 23 subordinate councils in various locations throughout the world. These have been the secret headquarters of the world revolutionary movement ever since.

Long before Marconi invented radio, scientists in the Illuminati had found a means for Pike and the heads of his councils to communicate secretly. It was the discovery of that secret which enabled intelligence officers to understand how apparently unrelated incidents took place simultaneously

throughout the world, developing into a war or a revolution.

Pike's plan was as simple as it has proved effective. It called for Communism, Naziism, political Zionism and other international movements to be organized and used to foment three global wars and at least two major revolutions.

The first world war was to be fought to enable the Illuminati to destroy Czarism in Russia (as vowed by Nathan Rothchild) and transform her into a stronghold of atheistic communism. The differences stirred up by Illuminati agents between the British and German Empires were to be used to start this war. After the war's end, Communism was to be built up and used to destroy other governments and weaken all religions.

World War II, when and if necessary, was to be sparked by controversies between Fascists and political Zionists. Hilter was financed by Krupp, the Warburgs, the Rothchilds and other international bankers and the slaughter of thousands of Jews did not bother the Jewish bankers at all. It was considered necessary to create a world-wide hatred for the German people and precipitate the war.

The second world war was to be fought to destroy Naziism and to increase the power of political Zionism by establishment of the State of Israel in Palestine. During this war international communism was to be built up until it equaled in strength

that of united Christendom. At that point, it was to be contained and kept in check until required for the final social cataclysm. As we know now, Roosevelt, Churchill and Stalin put that exact policy into effect, and subsequent Presidents continued that same strategy.

World War III is to be brought about by using controversies the agents of the Illuminati (operating under new names) are now arranging between the political Zionists and leaders of the Moslem world. That war is to end in the mutual destruction of all Islam and political Zionism (Israel).

At the same time the remaining nations, once more divided on this issue, will be forced to fight themselves into a state of complete exhaustion, physically, mentally, spiritually, and economically.

Pike himself foretold all this in a statement made to Muzzini August 15, 1871 (catalogued in the British Museum, London).

“We shall unleash the nihilists and the atheists and we shall provoke a great social cataclysm which, in all its horror, will show clearly to all nations the effect of absolute atheism, the origin of savagery and of most bloody turmoil. Then everywhere, the people forced to defend themselves against the world minority of revolutionaries will exterminate those destroyers of civilization. The multitudes disillusioned with Christianity will receive the true light with the universal manifestation of the pure

doctrine of Lucifer, brought finally out in public view; a manifestation which will result from a general reactionary movement which will follow the destruction of Christianity and atheism, both conquered and exterminated at the same time.”

In 1872, Pike appointed another Italian revolutionary leader, Adrian Lemmy, Muzzini’s successor. He was succeeded by Lenin and Trotsky, then by Stalin. Revolutionary activities of all those men were financed by British, German and American international bankers, all dominated by the House of Rothchild.

While the general public has been brainwashed through the mass communications media into believing that communism is a movement of the so-called workers, both British and American intelligence officers have authentic documentary evidence that the liberals, operating through their international banking houses (particularly the House of Rothchild) have financed both sides in every war and revolution since 1776.

Those who today comprise the conspiracy (the CFR in the U.S.) direct our government, whom they hold and use to fight wars like Viet Nam – created by the United Nations, so as to further Pike’s Illuminati plans.

The headquarters of the great conspiracy in the late 1700’s was in Frankfurt, Germany, where the House of Rothchild had been established.

After the Bavarian government expose' in 1786, they moved headquarters to Switzerland, then to London. Since World War II the headquarters of the American branch has been the Harold Pratt building in New York. The Rockefellers, originally proteges of Jacob Schiff, have taken over the overall manipulation of finances for the Illuminati in America.

In the final phases of the conspiracy the one world government will consist of a King-Dictator (head of the United Nations), and the CFR, a few billionaires, economists and scientists who have proven their devotion to the great conspiracy. All others are to be integrated into a vast conglomeration of mongrelized humanity, actually slaves!

The real foundations for the plot to take over the United States were laid during the Civil War. John Wilkes Booth was a member of a secret conspiratorial group, but because there were a number of important government officials involved, the name of the group was never revealed and became a mystery. This was exactly as happened with the assassination of John Kennedy.

The ending of the Civil War destroyed temporarily all chances for the House of Rothchild to get a grip on our money system such as had been previously acquired in Europe.

Shortly after the Civil War a young immigrant, Jacob H. Schiff arrived in New York. Rothchild

had recognized in this son of a Rabbi, not only a potential money wizard but, more importantly, his latent Michiavellian qualities.

After a comparatively brief training period in the Rothchild's London bank, Schiff left for America with instructions to buy into a banking house which was to be the spin-board to acquire control of the entire money system of the U. S.

Actually Jacob came to carry out four specific assignments. Number one, and most important, to acquire control of America's money system; (2) find desirable men who, for a price, would be willing to serve as stooges for the great conspiracy and promote them into high places in our federal government, our Congress, the Supreme Court and all federal agencies; (3) create minority group strife throughout the nation, particularly between whites and blacks; (4) create a movement to destroy religion in the U. S., with Christianity to be the chief target.

Schiff's first step was to buy into a banking house he could absolutely control and mold for that primary objective of tapping the U.S. money system. After careful scouting around, Jacob bought a partnership in a firm called Kuhn and Loeb.

Shortly after he became a partner, he married Loeb's daughter Teresa, bought out Kuhn's interest and moved the firm to New York. Throughout his career, this blend of Judas and Michiavelli, the

first heirach of the Illuminati great conspiracy in America, posed as a generous philanthropist and a man of great holiness.

To achieve control of the U. S. money system, Schiff had to secure the full cooperation of the then big banker elements in the country. This was easier said than done.

Wall Street was the heart of the American money mart and J.P. Morgan was its dictator. Next in line were the Drexels and the Biddles of Philadelphia. All the other financiers, big and little, danced to the music of those three houses, particularly to that of Morgan. All of those three were proud, haughty, arrogant potentates.

For the first few years they viewed the little be-whiskered man from the German ghettos with utter contempt, but Jacob knew how to overcome that. He threw a few Rothchild bones to them, the distribution in America of desirable European bond and stock issues. Then he discovered he had a still more potent weapon in his hands.

In the decades after the Civil War American industry began to boom. There were great railroads to build and the oil, mining, steel, textile industries were bursting with growth. This called for vast financing, much of which had to come from abroad, which meant the House of Rothchild. Schiff came into his own, playing a very crafty game. He financed Standard Oil for John D.

Rockefeller, the railroad empire for Edward R. Harriman and the steel empire for Andrew Carnegie.

Instead of grabbing all the other industries for Kuhn, Loeb and Company, he opened the doors of the House of Rothchild to Morgan, Biddle and Drexel, setting up London, Paris, and other European branches for those three; always in partnerships with Rothchild subordinates.

Thus, at the turn of the century, Schiff had gained a tight control of the entire banking fraternity on Wall Street. By then, with Schiff's help, this included Leyman Brothers, Goldman Sachs and other internationalist banks, headed by men chosen by the Rothchilds. This meant control of the nation's money powers, and he was then ready for the giant step of entrapment of our national money system.

Under our Constitution all control of our money system had been vested solely in our Congress. Schiff's next step was to seduce Congress to betray that Constitutional edict by surrendering that control to the hierarchy of the Illuminati great conspiracy.

In order to legalize the surrender and thus make the people powerless to resist, Congress must enact special legislation. To accomplish this Schiff would have to infiltrate both houses of Congress with men powerful enough to railroad Congress into passing such legislation.

Equally, or even more important, he would have to plant a man in the White House, a president without integrity and without scruples to sign that legislation into law. To do this he had to get control of a major political party.

The Democratic party was the more vulnerable. Except for Grover Cleveland, they had been unable to land their man in the White House since before the Civil War. There were two reasons: the poverty of the party and there were considerably more Republican-minded voters than Democrats. The poverty matter was no great problem, but voters would be more difficult to secure.

To solve this problem Schiff employed an atrocious and murderous method, illustrating again how little the conspirators care about their own racial brethren. Around 1890, there broke out a nationwide series of pogroms in Russia, slaughtering Jewish men, women, and children. Similar pogroms of slaughter of innocent Jews were also carried out in Poland, Romania and Bulgaria.

All of these brutal killings were planned and promoted by Rothchild agents. As a result, for two or three decades terrified Jewish refugees from all those nations swarmed into the U.S. as the pogroms continued. These refugees were aided by self-styled "humanitarian" committees set up by Schiff, the Rothchilds, and all the .

In the main, the refugees streamed into New York but the Schiff-Rothchild humanitarian committees found ways to shuffle them into other large cities, such as Chicago, Boston, Philadelphia, Detroit, Los Angeles, etc. All of them were quickly transformed into naturalized citizens and educated to register as Democrats.

Thus, all of that so-called minority group became solid Democratic voter blocs in their communities, all controlled and maneuvered by their so-called benefactors. Shortly after the turn of the century they became vital factors in the political life of our nation. That was one of the methods Schiff employed to plant men like Nelson Aldrich in our Senate and Woodrow Wilson in the White House.

Another assignment given Schiff in the beginning was to destroy the unity of the American people by creating minority group and racial strife. By the pogrom-driven Jewish refugees into America, Schiff was creating a ready-made minority group for that purpose. However, the Jewish people, made fearful as a whole by the pogroms, could not be depended upon to create the violence necessary to destroy the unity of the American people.

Within America, however, there was an already made-to-order (although as yet a sleeping), minority group, the Negroes. They could be sparked into so-called demonstrations, rioting, looting, murder and every other type of lawlessness. All this was necessary to incite and arouse them.

Together, those two minority groups, properly maneuvered, could be used to create exactly the kind of strife in America the Illuminati would need to accomplish their objective. Thus, at the same time that Schiff and his co-conspirators were laying plans for the entrapment of our money system, they were also perfecting plans for hitting the unsuspecting American people with an explosive and terrifying racial upheaval.

It was in 1908 Schiff decided the time had come to seize our money system. His chief lieutenants in that seizure were Colonel Edward Mandell House (whose entire career was that of chief executive and courier for Schiff), Bernard Baruch, and Herbert Leyman. In the fall of that year, there was a secret conclave at the Jekyll Island Hunt Club in Georgia, owned by J.P. Morgan. Among others present were J.P. Morgan, John D. Rockefeller, Senator Nelson Aldrich, Schiff, Stillman and Vanderbilt (New York National City Bank), W. and J. Seligman, Eugene Meyer, and Paul Warburg. The international bankers in America, members of the Illuminati hierarchy, were all present.

A week later, they emerged with a plan they called the Federal Reserve System. Senator Aldrich was to push it through Congress, but they were not yet ready. First they had to plant their man in the White House to sign the Federal Reserve Act into law. Even if the Senate passed it unanimously, the newly elected President Taft would promptly veto it, so they waited.

In 1912, their man, Woodrow Wilson, was elected to the Presidency. Immediately after his inauguration, Senator Aldrich railroaded the Federal Reserve Act through both houses of Congress. Wilson promptly signed it into law.

This was done on December 23, 1913, when all the members of Congress (except for several carefully picked Representatives and three equally carefully chosen Senators) were away from Washington.

On that day in December the men sent to Washington to safeguard the nation's interests delivered the destiny of our nation into the hands of two aliens from eastern Europe, Jacob Schiff and Paul Warburg. Warburg was a very recent immigrant who came here on orders from Rothschild for the express purpose of blueprinting the Federal Reserve Act.

The vast majority of the American people think that the Federal Reserve System is a government owned agency. That is positively false, for all of the stock of the Federal Reserve is owned by the member banks. The heads of the member banks are all members of the hierarchy of the great Illuminati conspiracy, known today as the CFR. (The details of that act of treason are documented in "The Federal Reserve Conspiracy" by Eustice Mullins, Christian Education Association, 350 Chestnut St., Union, New Jersey.)

The Federal Reserve Act gave the conspirators control of our money system but did not touch the earnings of the people, for the Constitution specifically forbade a tax on income. However the Illuminati blueprint for one world enslavement calls for the confiscation of all private property and control of individual earning power. This (stressed by Karl Marx) had to be accomplished by a progressive graduated income tax. Such a tax could not lawfully be imposed upon the American people. Only an amendment to the Constitution could give the federal government such confiscatory powers.

For the plotters this was the next step. The same elected leaders in both houses of Congress and the same Woodrow Wilson, who engineered the Federal Reserve law, amended the Constitution to make the Federal Income Tax (the 16th Amendment) the law of the land. Both are illegal under our Constitution.

No one seemed to notice that the 16th amendment was designed to rob the people of their earnings via the income tax provision. The plotters did not fully use that provision until World War II when that great “humanitarian,” Franklin D. Roosevelt, applied a 20% withholding tax on all small wage earners and up to 90% on higher incomes. He faithfully promised it would be for the duration of the war, but what was a promise to such a man?

The 16th amendment income tax trap was designed to rob and confiscate the earnings only of the common people. It was never intended to even touch the

huge incomes of the super-rich. Together with the 16th amendment, was created what they called the tax-free foundations. This enables such so-called foundations to avoid virtually all income taxes.

The excuse used was that the earnings of the tax-free foundations would be devoted to humanitarian philanthropy. We now have many Rockefeller foundations, the Carnegie Endowment Fund, Ford Foundation, Mellon Foundation, and hundreds of similar tax-free foundations.

What kind of philanthropy do these foundations support? They finance all the civil rights groups which have created chaos and rioting nationwide; the Martin Luther Kings; the Center for the Study of Democratic Institutions (Ford) in Santa Barbara, nicknamed “Moscow West” and headed by Hutchins, Walter Reuther, Irvine Cannon, etc., etc. The tax-free foundations finance those who are doing the job for the Illuminati great conspiracy.

With Wilson completely under their control the masterminds of the great conspiracy put in motion their next, and what they hoped would be final step to achieve one world government. The first was to be World War I.

Why war? The only excuse for a one world government is that it will supposedly insure peace. The only thing which will make people cry for peace is war. It brings chaos, destruction and exhaustion to the winner as well as the loser and economic ruin to both.

From 1814 to 1914, the world as a whole was at peace. The Franco-Prussian, the U.S. Civil War and the Russo-Japanese War could be termed local disturbances which did not greatly affect the rest of the world. The great nations were prosperous, the people fiercely nationalistic and proud of the sovereignties.

There would have to be a frightful and horribly devastating war, a world war which would leave no major nation untouched. The cry for peace must be made universal. This was the same format set by the Illuminati and Nathan Rothchild at the turn of the 19th century, using the Napoleonic wars and Congress of Vienna. The 1914 conspirators planned to eliminate the 1814 “fly in the ointment.” They would make sure that after this new world war, there would be no Czar of Russia to block the machinery.

History records that World War I was precipitated by a trivial incident (the kind of incident both Weishauph and Albert Pike had incorporated in their blueprints), the assassination of an Austrian archduke, arranged by the Illuminati masterminds. The war involved Germany, Austria-Hungary and their allies against France, Britain and Russia. Only the United States was not involved in the first two years.

By 1917, the conspirators had achieved their primary objective. All of Europe was in a state of

destitution and people were war-weary and crying for peace. The outcome too was set. The United States would be hurled in on the side of the Allies immediately after Wilson's reelection. Then there would be complete victory for the allies.

When Wilson was campaigning for re-election in 1916, his chief appeal was to re-elect the man who kept your sons out of the war. During that same campaign the Republican party publicly charged that Wilson had long ago committed himself to throw us into the war. They charged that if he would be defeated, he would accomplish that act during his few remaining months in office. If re-elected, he would hold off until after re-election; but that time the American people looked upon Wilson as a sort of god-man.

Wilson was re-elected and as per the schedule of the conspirators he hurled us into the war of 1917. He used the sinking of the Luisitania as an excuse, a sinking which was also prearranged. Roosevelt, also a god-man in the eyes of the American people, followed the same technique in 1941 when he used the prearranged Pearl Harbor for throwing us into World War II.

Exactly as the conspirators planned, victory for the Allies would eliminate all the monarchs of the defeated nations and leave all their people leaderless, confused and perfectly conditioned for the one world government.

However, there still would be the same obstacle which balked the Illuminati and Rothchild at the Congress in Vienna after the Napoleonic Wars. Russia would be on the winning side this time as she had been in 1814. Under the Czarist regime this had been the one country in which the Illuminati had never made any headway, nor had the Rothchilds ever been able to infiltrate Russian banking interests. Even if the Czar could be enticed into a so-called League of Nations it was a foregone conclusion that he would never go for a one world government.

Even before the outbreak of World War I the conspirators had a plan in the making to carry out Nathan Rothchild's vow of 1814 – to destroy the Czar and murder all possible legal heirs to the throne. This would have to be done before the close of the war and the Russian Bolshiviks would be their instruments.

From the turn of the century the chiefs of the Bolsheviks were Nikolai Lenin, Leon Trotsky and Joseph Stalin. Prior to the outbreak of the war, Lenin headquartered in Paris. After the outbreak, Switzerland became his haven. Trotsky's headquarters were on the lower east side of New York City, largely the habitat of Russian Jewish refugees. Both men lived well; neither had a regular occupation or any visible means of support, yet both always had plenty of money.

From the outset of the war mysterious "goings on"

were taking place in New York. Night after night Trotsky darted furtively in and out of Jacob Schiff's palatial mansion. Those same nights, there were gatherings of hoodlums on the lower east side, all Russian refugees, at Trotsky's headquarters. All were going through some mysterious sort of training process, shrouded in mystery. Nobody talked, although it did leak that Schiff was financing all of Trotsky's activities.

Suddenly Trotsky vanished with 300 of his trained hoodlums. They were on the high seas in a Schiff-chartered ship bound for a rendezvous with Lenin and his gang in Switzerland. On that ship was 20,000,000 in gold, provided by Schiff for the Bolshevik takeover of Russia.

In anticipation of Trotsky's arrival, Lenin prepared to throw a party in his Swiss hideaway. Men of the very highest places in the world were to be guests at that party. Among them were: Colonel Mandell House (Woodrow Wilson's close pal and Schiff's special and confidential messenger); Warburg of the German banking clan financing the Kaiser (whom the Kaiser had rewarded by making him head of the secret police of Germany); the Rothchilds of London and Paris; Litvinoff, Kagonovich, and Stalin.

At this time England and France were long into war with Germany and on February 3, 1917, Wilson had broken off all diplomatic relations with

Germany. Therefore Warburg, Colonel House, the Rothchilds and all others were technically enemies, but Switzerland was neutral ground where enemies could meet and be friends, especially if they had some scheme in common.

That Lenin party was almost wrecked by an unforeseen incident. The Schiff-chartered ship was taken into custody by a British warship. Schiff quickly rushed word to Wilson to order the British to release the ship. Wilson warned the British if they refused to release it, the U.S. would not enter the war in April as he had faithfully promised a year earlier. Trotsky arrived in Switzerland, and the Lenin party went off as scheduled.

They still faced what would have been the insurmountable obstacle of getting the Lenin-Trotsky band of terrorists across the border into Russia. However, Warburg, chief of German secret police, loaded them into sealed freight cars and made all the necessary arrangements for their secret entry into Russia. The rest is history. Revolution in Russia exploded and all members of the royal Romanoff family were murdered, according to plan.

Communism (so called) is an integral part of the Illuminati's great conspiracy for the enslavement of the entire world. It is merely their weapon and bogey-man word to terrify the peoples of the whole world.

The conquest of Russia and creation of communism was in great part organized by Schiff and the

other international bankers right in New York City. Just a few years ago, Charlie Knickerbocker, a Hirsch newspaper columnist, published an interview with John Schiff, grandson of Jacob, in which Schiff confirmed the entire story and named the figure Jacob contributed, \$20,000,000.

If anyone still has even a remote doubt that the entire menace of Communism was created by the masterminds of the great conspiracy right in New York, consider the following historical facts. All records show that when Lenin and Trotsky engineered the capture of Russia, they operated as heads of the Bolshevik party. Bolshevism is a purely Russian word. The masterminds realized that Bolshevism could never be sold as an ideology to any but the Russian people.

In April, 1918, Jacob Schiff dispatched Colonel House to Moscow with orders to Lenin, Trotsky and Stalin to change the name of their regime to the Communist Party and to adopt the Karl Marx manifesto as the constitution of the Party. They obeyed and that year of 1918 was when the Communist Party and the menace of Communism came into being.

All the great nations were war-weary, devastated, mourning their dead. Peace was the great universal desire. When Wilson proposed a League of Nations to ensure peace, all the nations jumped on that bandwagon, without even stopping to read the fine print in the insurance policy. That is, all but

one. The United States, the one that Schiff and his co-conspirators least expected would balk.

This was their fatal mistake in that early plan to have all nations accept the plan almost sight unseen. There was one man in the Senate who saw through that scheme, just as did the Russian Czar in 1814. He was a man of great political stature, highly respected and trusted by all members of both Houses of Congress and by the American people. This great and patriotic American was Henry Cabot Lodge. Lodge completely unmasked Wilson and kept the U. S. out of the League of Nations.

Schiff and his co-conspirators did set up the National Association for Advancement of Colored People (NAACP) and the Anti Defamation League in 1913. Both were to create the necessary strife. In the early years the ADL operated very timidly perhaps in fear of a pogrom-like action by an aroused and enraged American people. The NAACP was practically dormant because its white leadership did not realize that they would have to develop firebrand Negro leaders such as Martin Luther King to spark the then relatively content mass of Negroes.

Schiff was also busy developing and infiltrating the stooges to serve in all high places in our Washington government and in the job of acquiring control of our money system and the creation of the 16th amendment. He was involved heavily in the plot to take over Russia as mentioned earlier.

He became so occupied with all those jobs that he completely overlooked the supreme task of acquiring complete control of our press. That oversight was the direct cause for Wilson's failure to lure the United States into the League of Nations. Wilson decided to go to the people to overcome the opposition of the Lodge-controlled Senate. Despite his established but phony reputation as a humanitarian, he found himself faced by solidly united people and by a loyal press whose only ideology was Americanism and the American way of life.

At that time, due to the ineptness of both the ADL and NAACP, there were no organized minority groups, no Negro problems, no anti-Semitic problem to sway the peoples' thinking. There were no lefts and no rights, no prejudices for crafty exploitation. Thus Wilson's appeals fell on deaf ears and that was the end of the conspirators great "humanitarian." He quickly abandoned his crusade and returned to Washington where he shortly died - an imbecile, brought on by syphilis. This was the end of the League of Nations as a corridor into one world government.

Although that debacle was a terrible disappointment to the masterminds of the Illuminati conspiracy, they were not dismayed. As has been repeatedly stressed, the enemy never quits. They simply decided to reorganize and try again.

By this time, Schiff was very old and slow. He

knew the conspiracy needed new, young and more active generalship. So, on his orders, Colonel House and Bernard Baruch devised and set up what they called the Council on Foreign Relations (CFR) – the new name under which the Illuminati would continue to function in the U. S.

The hierarchy, officers and directors of the CFR was composed principally of the original descendents of the original Illuminati, many of whom had abandoned their old family names and acquired new Americanized names.

Membership of the CFR is approximately 1000 and contains the heads of virtually every industrial empire in America, the international bankers and the heads of the tax free foundations who are officers and/or active CFR members. In short, all the men who provide the influence to elect the CFR chosen U. S. presidents, congressmen, senators, and who decide the appointments of cabinet officers and of every important federal agency are members of the CFR.

U. S. presidents who were members of the CFR include: Franklin Roosevelt, Herbert Hoover, Dwight Eisenhower, John Kennedy and Richard Nixon. Other members considered for the Presidency were Thomas E. Dewey and Adlai Stevenson.

Among important CFR cabinet members are John Foster Dulles, Allen Dulles, Cordell Hull, John J. McCloy, Morganthau, Clarence Dillon, Dean Rusk,

and Robert McNamara. Others include Alger Hiss, Ralph Bunch, Harry Dexter White, Owen Lattimore, Phillip Jesse, ect., etc. Simultaneously thousands of homosexuals and other blackmailable characters were flooded into all federal agencies from the White House down.

The CFR set up subsidiaries to whom were assigned special objectives. To name a few: The Foreign Policy Association (FPA); World Affairs Council (WAC); and the notorious 1313 in Chicago. In addition, there were subsidiaries in every state in the union to whom were assigned the various state operations.

Simultaneously, the Rothchilds set up similar control groups in England, Germany, France and other nations to control world conditions and cooperate with CFR to bring about another world war.

The CFR's first and foremost job was to secure complete control of our mass communications media. Control of the press was assigned to Rockefeller. The late Henry Luce was financed to set up a number of national magazines (Life, Time, Fortune, U.S.S.R., and others). The Rockefellers, directly or indirectly financed the Cowl brothers Look Magazine and a chain of newspapers, and Sam Newhouse to buy up and build a chain of newspapers. The late Eugene Meyer, one of the founders of CFR, bought the Washington Post, Newsweek and other publications.

At the same time, CFR began to develop and nurture a new breed of columnists and editorial writers such as Walter Lippmann, Drew Pearson, the Alsops, Herbert Matthews, Erwin Cannon, and others. They called themselves liberals; proclaimed that Americanism is isolationism; that isolationism is war mongering; and that anti-communism is anti-Semitism and racism.

All that took time, but today our entire press, except for some local small town papers and weeklies published by patriotic organizations is completely controlled by CFR stooges. Thus, they finally succeeded in breaking us up into a nation of quarrelling, wrangling, squabbling, hating factions. To the Leymans, Goldman, Sachs and the Warburgs the CFR assigned the job of getting control of the motion picture industry (Hollywood), radio and TV, and they succeeded.

One of Schiff's assignments was to create a movement to destroy religion in the United States with Christianity as the chief target. He assigned that job to Rockefeller who reasoned that the destruction of Christianity could be accomplished only by those who are entrusted to preserve it, by the pastors.

As a starter, John D. Rockefeller picked up a minister named Harry F. Ward, teaching religion at Union Theological Seminary. This man proved a very willing Judas and in 1907, he was financed to set up the Methodist Foundation for Social Service.

Ward's job was to teach bright young men to become so-called ministers of Christ and to place them in pastorates. While teaching them to become ministers, He also taught them how to very subtly and craftily preach to their congregations that the entire story of Christ is a myth, and to cast doubts on the divinity of Christ and the Virgin Mary. Not to be a direct attack, but by crafty insinuation, this was to be applied particularly to the youth in the Sunday Schools.

In 1908 the Methodist Foundation of Social Service changed its name to the Federal Council of Churches. By 1950 FCC was becoming very suspect, so again they changed their name to the National Council of Churches. That same "destroy religion" process has been infiltrated into other denominations. You will note that many racial disorders are led by ministers.

Harry F. Ward was also one of the founders of the American Civil Liberties Union, a notorious pro-communist organization. He was the actual head of it from 1920 till 1940. He was also co-founder of the American League against War and Fascism, which under Browder became the Communist Party of the U.S.

In short, Ward's entire background reeked of Communism and he was identified as a member of the Communist Party. This was the man John D. Rockefeller hand picked and financed to destroy the Christian religion in accordance with orders given to Schiff by the Rothschilds.

The Wilson League of Nations flop brought Schiff and his group to the realization that control of just the Democratic Party was not enough. True, they could create a crisis during a Republican administration (as in 1929 with the manufactured crash and depression) which would put another Democrat into the White House. However, a four year disruption in their control of our foreign relation policies could play havoc with the progress of their conspiracy. It could even break up their entire strategy.

After the Wilson disaster, they began to formulate plans to gain control of both our national parties. This posed problems of manpower; stooges in the Republican Party, also added manpower inside the Democratic Party. Control of the President would not be enough; there must be trained men for his entire cabinet. Every important office must be held by tools chosen by the CFR to give absolute control of our policies, both domestic and foreign.

This would require a reserve pool of trained workers instantaneously ready for administrative changes. All such men would have to be of national reputation, high in the esteem of the people, but men without honor, scruple of conscience; men vulnerable to blackmail. They succeeded well.

The conspirators knew the Moscow gang could not become a threat until and unless the whole world accepted the communist regime as the legitimate government of Russia. Only one thing could accomplish that, recognition by the United States. They

reasoned that the whole world would follow the United States' lead. That's when the Wilson flop very nearly wrecked the entire plot.

Throughout the following three Republican administrations the CFR pulled every trick in their bag to induce Harding, Coolidge and Hoover to grant that recognition, but all three refused. As a result, in the late 1920's the Stalin regime was in dire straits. Despite all purges and secret police controls, the Russian people were growing more and more restless. As a matter of record (admitted by Litvinoff) during 1931-1932, Stalin and his whole gang were always packed and ready for instant flight.

In November, 1932 the conspirators achieved their greatest coup. They landed Franklin D. Roosevelt in the White House. Crafty, unscrupulous and utterly without conscience, without even asking consent of Congress, he unlawfully proclaimed recognition for the Stalin regime. As the conspirators had hoped, the whole world did follow our lead.

Automatically this squelched the previously growing resistance movement of the Russian people and launched the greatest menace the civilized world has ever known. The rest is too well known to need repeating. Roosevelt and his State Department kept building up the communist menace right here in our own country and thus throughout the world. He perpetrated the Pearl Harbor atrocity, for his excuse to get us into World War II.

Roosevelt had secret meetings with Stalin in Yalta and he, with Eisenhower's help, delivered the Balkans and Berlin to Moscow. Not only did he drag us into that new corridor to one world government, the United Nations, but actually schemed all the arrangements to plant it within our country.

The day Roosevelt entered the White House; the CFR conspirators regained full control of our foreign relations machinery and firmly established the United Nations as the housing for the Illuminati one world government.

As previously stated, the maneuverings necessary to create another League of Nations to house such a government required another World War. The problem was that Europe was at peace, with no major quarrels and as yet the Moscow tools were not strong enough to start a war.

The conspirators needed an incident to kindle a war. They found it in a little, inconspicuous and repulsive man who called himself Adolph Hitler. Strangely enough, the little clown could deliver a rabble rousing speech and he did have a certain kind of magnetism. The new authorities in Germany did not want any more wars and promptly jailed the obnoxious upstart.

It was decided that Hitler, properly directed and financed could be the key to another world war. While he was in prison, they had Rudolph Hess and Hermann Goering write a book titled "Mein Kampf," and attributed the authorship to Hitler.

The conspirators next arranged a wide circulation of the book among the German people to arouse a fanatical following for Hitler. On his release from prison (also arranged by the conspirators) they began to groom and finance him to travel over Germany. Soon he gathered a growing following. The Rothchilds, the Warburgs and others of the conspirators provided all the money he needed.

Gradually, Hitler became the idol of the German people and overthrew the Von Hindenburg government. Hitler became the new Fuehrer, but that still was no reason for a war.

The conspirators realized they would have to create such a frenzy as to cause the German people to throw caution to the wind and at the same time horrify the whole world. "Mein Kampf" was actually a follow-up of Karl Marx's book "A World Without Jews." The conspirators suddenly remembered how the Schiff-Rothchild agents engineered the pogroms in Russia which slaughtered thousands of Jews and created a worldwide hatred for Russia. They decided to use that same thing to inflame the new Hitler-led German people into a murderous hatred of the Jews.

Thus, craftily inspired and coached by his financial advisors, Hitler blamed the Jews for the hated Versailles Treaty and for the financial ruination which followed the war.

The rest is history with concentration camps and

incineration of hundreds of thousands of Jews. Many of the Hitler soldier-executioners in those camps had previously been sent to Russia to acquire their arts of torture and brutalization so as to emphasize the horrors of the atrocities.

All this created a new worldwide hatred for the German people but still did not provide a cause for war. Hitler demanded the Sudatenland and got it. He demanded territories in Poland and the French Saar which were rejected. Next came his pact with Stalin. While Stalin marched into one part of Poland, Hitler launched a blitzkrieg on Poland from his side. The conspirators finally had their new world war and what a horror it was!

In 1945, the conspirators finally set up the United Nations, the new housing for their world government. Amazingly, the American people hailed this foul creation as the holy of holies. Even after all the true facts about how the UN was created were revealed, they continued to worship that evil outfit. Even after Alger Hiss was unmasked as a Soviet spy and traitor, the American people continued to believe in the UN. Even after the revelation of the secret agreement between Hiss and Molotoff that a Russian would always be the head of the military secretariat (and that by that token, the real master of the UN), most of the American people continued to believe that the UN could do no wrong.

Even after the truth about the Korean War was re-

vealed; how the Russian general (head of the UN military secretariat) was given a leave of absence by the UN to take command of the North Korean and Chinese forces who were fighting the so-called police action, people still believed in the UN.

The UN Charter was written by traitor Alger Hiss, Molakoff, and Vichinski. In their secret meetings at Yalta, Roosevelt and Stalin, at the behest of the Illuminati (operating as the CFR) decided that the UN must be placed on American soil.

Most of the UN Charter was copied intact, word for word, from the Marx manifesto and Russia's so-called Constitution. It is said that the only two senators who voted against the UN treaty were also the only two who had read it.

Since the UN was founded, communist enslavement has grown from 250,000,000 to one billion. Since the UN was established "to insure peace" there have been at least 20 major wars, incited by the UN. Under the UN setup American taxpayers have been forced to make up the UN treasury deficits of many millions because of Russia's refusal to pay her share. The UN has never passed a resolution condemning Russia or its satellites, but always condemns our allies.

The UN helps Russia's conquest of the world by preventing the free world from taking any action whatsoever, except to debate each new aggression in the UN General Assembly. At the time of the Korean War there were sixty nations in the UN, yet 95% of the UN

forces were American and we paid almost 100% of the cost.

The UN policy in the Korean War was to prevent winning the war. All of MacArthur's battle plans had to be referred first to the UN to be relayed to the Commander of the North Koreans and Red Chinese. Any future wars, fought by our sons under the UN flag, would have to be fought under the control of the UN Security Council.

The UN has never done anything about the 80,000 Russian Mongolian troops that occupied Hungary. Where was the UN when the Russians slaughtered the Hungarian freedom fighters? Again and again and again, we have been startled, shocked, bewildered and horrified by their mistakes in Berlin, Korea, Laos, Katanga, Cuba, Viet Nam; mistakes that always favor the enemy, never the U.S. Under the law of averages, they should have made one or two mistakes in our favor, but they never did!

The answer is the CFR and the parts played by their subsidiaries and stooges in Washington. Complete control of our foreign policy in Washington is the key to success of the Illuminati one world plan.
